Other Important Dates to Remember:

- July 20 If you will complete a degree or certificate program during Summer term 2010, you must apply for graduation by this date in order to receive your diploma.
- August 2 End of Summer Term
- August 22 First Day of Classes
- December 2 If you will complete a degree or certificate program during Fall term 2011, you must apply for graduation by this date in order to receive your diploma.
- December 16 End of Fall Term 2011



Why Do I Need a Program of Study?

When you meet with a student advisor, you will develop a plan that will serve as a guide for completing your degree or certificate program at NWFSC. While you can certainly follow the guide in the college catalog, you may miss out on some valuable information. Ms. Sandlin will be able to help you plan the order of when to take classes and will also be able to tell you which courses are only offered once a year. There have been occasions when a student had to wait two semesters to take the last course needed for their degree because they did not seek out guidance early in their college career.

Raidernet: Information is Power!

Are you using all the great information available to you at Raidernet? You can download a student copy of your transcript. You can do a degree audit to see exactly which requirements you have completed and which requirements you must complete for your degree.

Go to www.nwfsc.edu and sign on to Raidernet. The directions on how to sign in the first time is provided there.

Your FCCPC or CDA is Worth College Credit!



If you have a current FCCPC or CDA, you may be eligible to earn college credit for the credential. In order to do so you must:

1. Have a current FCCPC or CDA.
2. Have completed 15 credit hours at NWFSC.

If you meet the two requirements above and have not already done so, submit a copy of your certificate to Ms Sandlin by bringing it to her office at Bldg. M, Room 104 on the Niceville campus.

I Don't Plan to Participate in the Graduation Ceremony. Why Do I Need to Apply to Graduate?

The purpose of the graduation ceremony is to publicly celebrate your accomplishments and share this with family and friends. However, you are not required to do so.



Still, if you wish to complete your certificate or degree program and receive your diploma, **you must complete an Application for Graduation.** The purpose of this application is to signal to the student services office that they need to review your records and determine that you are eligible for graduation. **If you fail to do this important step, you will not receive your diploma!**

What are the requirements for membership?

- The student must be currently enrolled at NWFSC.
- The student must have a minimum NWFSC cumulative GPA of 2.0.
- The student must pay annual dues of \$10.00.

What is the purpose of ECSA?

- Promote professional growth and knowledge in early childhood education.
- Provide opportunities for early childhood students to associate with one another.
- Practice advocacy for children and families.
- Participate in community service activities particularly on behalf of young children and their families.

How will I benefit from membership?

- You will have an opportunity to get acquainted with other early childhood students and share information and support as you attend NWFSC.
- You will have an opportunity to gain leadership skills if you choose to take a leadership role in the organization.
- You can participate in community service activities that will help meet a requirement for renewal of your Florida Director Credential.
- Your membership will meet one of the requirements for renewal of the CDA and/or FCCPC.

What are the Early Childhood Education Certificate Programs at NWFSC?

NWFSC has four certificate programs in early childhood education. In the course of working toward completion of the A.A.S. or A.S. degree in early childhood education, you will also meet the requirements to earn the diplomas for these certificate programs. **In order to receive the diplomas for these programs, you must complete an application for graduation.**

NWFSC offers the Associate of Applied Science Degree and the Associate of Science Degree in Early Childhood Education.

Early childhood students may choose to earn either the Associate of Applied Science (A.A.S.) Degree or the Associate of Science (A.S.) Degree.

The key differences are:

- ❖ LIN1670 (Writing and Grammar) will meet the Communications requirement for the A.A.S. degree. Students seeking the A.S. degree must take ENC1101 (English Composition 1).

- ❖ MTB1103 (Business Math) will meet the Math requirement for the A.A.S. degree. Students seeking the A.S. degree must take a general education Gordon rule mathematics course. See list of courses in NWFSC Catalog.

- ❖ The A.A.S. degree is not a transferable degree.

- ❖ The A.S. degree will transfer to a **limited** number of Baccalaureate degree programs in Florida.
